#### **Legislative Report**

The Illinois legislature is not in session. Meantime, The Illinois Association of County Veterans Assistance Commissions, being led by Lake County VAC will be chairing a committee of key veterans groups such as American Legion, VFW, AMVETS, MOAA (North Shore & Chicago), and others to develop a legislative plan for 2026 with focus on addressing Illinois VAC needs by updating the Illinois Military Assistance Act of 1947.

In commemoration of our recent Veterans Day, and on behalf of our Chapter I sent short letters to the Illinois Governor and the McHenry County board expressing our thanks as well as just raising the flag. It's important to maintain these relationships particularly now as funding is becoming more difficult. In addition, Chapter President John DeReu sent similar thank you letters to the Lake and Winnebago county boards.

#### **Volunteer Possibilities**

Consistent with the MOAA Motto "Never Stop Serving", consider serving at the Captain James A. Lovell Federal Health Care Center or Hines VA Hospital Fisher Houses. These programs would call for 2-6 people to prepare a Sunday night meal at one or the other location. The meal might be principally hamburgers and potato salad.

We also have an opportunity to serve at the USO at O'Hare. These shifts are four hours long and parking is provided in the short-term lot. Interacting with troopers probably gives those who serve more than the troops who are served.
